Dear Permanent Fund Dividend Applicant:

Your permanent fund dividend application has been selected for an eligibility determination because you have not lived in Alaska for 180 consecutive days in over five years. In accordance with 15 AAC 23.163(f) an individual with an absence totaling more than five years is presumed not to have the intent to return to Alaska and remain permanently in Alaska. Consequently, their absence is not allowable. Therefore, you are not eligible for a dividend payment unless you provide documentation that demonstrates to the department's satisfaction an intent at all times during your absence to return to Alaska and remain permanently in Alaska.

The questions in this questionnaire pertain to your intent to return to Alaska at all times during the calendar year 2004, the qualifying year for the 2005 dividend. Please read the entire questionnaire carefully, answer all questions and provide copies of any documentation requested or documentation that demonstrates your intent to return to Alaska to remain permanently. Please note that documents you send must either be originals or certified true copies. If a question is not applicable to your situation, write N/A as your answer. After you have fully answered all questions on this form, please sign and date the questionnaire on page 4 or it will not be considered valid.

Your timely response to this questionnaire is necessary to help complete your application file. Under 15 AAC 23.173(b), you are required to submit information requested by the Department of Revenue to determine if you qualify for a 2005 permanent fund dividend. ***You must provide the requested information by the later of December 31, 2005 or 30 days after the date of this request.*** This date can be found in the upper left hand corner of the address label. If you do not submit all requested information, your application ***will be denied*** in accordance with 15 AAC 23.173(d).

It is our goal to finish our review of all timely filed and complete 2005 applications no later than December 31, 2005. Please advise us in writing if you change your address or telephone number(s). Thank you for your cooperation.

Dear Applicant for the Permanent Fund Dividend:

We've selected your application for an eligibility review because you haven't lived in Alaska for 180 consecutive days in over five years.

Normally, under Alaska's codes, if you're gone from the state for more than five years, we must assume you don't intend to return and stay here. We need information from you so we can decide if you're eligible for a 2005 permanent fund dividend.

How can I show my intent to return and stay in Alaska?

Return this questionnaire before **December 31, 2005** or **within 30 days after the date of this request**—whichever is later. You can find our request date in the upper left hand corner of the address label.

Make sure you—

- read the attached questionnaire carefully
- answer all questions
- write N/A as your answer if a question doesn't apply to you
- send us copies of any document we ask for or that you know proves you intend to return and stay

These questions ask you about your intent to return to Alaska at all times during 2004—the qualifying year for the 2005 dividend.

Do I need to follow any special instructions?

All instructions are on the form, but please—

- note that documents you send must be either originals or certified true copies
- sign and date the questionnaire on page 4, or it won't be valid
- tell us in writing if you change your address or phone number

Remember, if you don't send all requested information on time, we must deny your application under 15 AAC 23.173(d).
